<b>Call to Order</b>	The Regular Meeting of the Board of Commissioners of Public Hospital District No. 2, Snohomish County, was called to order at 8:01 a.m. by President Langer.
<b>Approval of Minutes</b>	<b><i>Motion was made, seconded and passed unanimously to approve</i></b> the minutes of the Regular meeting on October 26, 2011.
<b>Board Finance Committee</b>	Commissioner Knutsen reported that the Finance Committee met on November 16, 2011 to review the financial statements and other ongoing issues.
<b>Profit &amp; Loss Statement</b>	Ms. King reported on the financials for September. (E:37:11).
<b>Authorization for Payment of Vouchers &amp; Payroll</b>	Warrant Numbers 10372 through 10404 for October for payment in the amount of \$221,477.55 were presented for approval (E:38:11). <b><i>Motion was made, seconded and passed unanimously to approve.</i></b>

**Board Executive  
Committee**

President Langer reported that the Executive Committee met on November 17, 2011 to review the agenda for the November 30, 2011 Board meeting. He also noted that there will not be a December Board meeting. President Langer congratulated Commissioners Knutsen & Knowles for their successful election results and welcomed Commissioner-elect Karianna Wilson.

**Program Oversight  
Committee Report  
&  
Recommendations**

Mr. Kosovich reported that the Program Oversight Committee met on November 9, 2011 & November 29, 2011 to review three proposals (E:39:11). The committee did not recommend funding the City of Lynnwood Jail Medical Services and will review further the proposal from the Puget Sound Christian Clinic. There are some budget and patient follow-up and liability questions that need to be addressed. The Committee recommended funding the Edmonds Community College Celebration of Food Festival in May 2012 with objective feedback from either a commissioner or staff member who attends the event.

***Motion was made, seconded and passed unanimously to approve*** this funding of \$5,000 on a one-time basis. There was no conflict of interest by any of the commissioners. President Langer suggested that Superintendent Zapora consider scheduling a Board Study Session for the 2<sup>nd</sup> quarter of 2012 to address policies for the commission in the provision of direct services.

**Marketing  
Report**

Superintendent Zapora welcomed Jennifer Piplic as the Director of Marketing. Ms. Piplic presented a written Marketing Report and current brochure (E:40:11). An annual report and new website are coming in early 2012. The commissioners are invited to register for attendance at one of the upcoming Community Leader meetings on December 2, 6 or 9; 8-9:30 AM.

Commissioner Williams suggested a possible commission funding to provide subsidies to low-income residents for participation in exercise classes. This item will be explored further in a study session in 2012 and will include a fitness center leader.

Report**

Superintendent Zapora reported on the upcoming Community Leader meetings with 52 in attendance to date and including a good mix of corporate and community leaders. He also reported on a possible community-wide Joe Piscatella event in Spring 2012 with the goal of 250 participants. This event will be a

discussion point at the Community Leader meetings.

President Langer recognized the services of board member Charles Day with a plaque and gift from the commissioners and superintendent. Commissioners Knutsen & Williams also thanked Commissioner Day for his service.

Mr. Al Rutledge commented on the possibility of the commission being involved in the Edmonds Methodist Church's food bank, the desire to have the commission expand from five to seven commissioners, and the need for funds to be given to in-patient home people because of the increased cost of health care and the budget concerns.

Ms. Marcy Shimada from the Edmonds Family Medical Center commented on the Puget Sound Christian Clinic's request for funding and had suggested that the clinic partner with Project Access.

President Langer recessed the regular meeting at 8:52 a.m. into Executive Session to discuss legal matters.

President Langer stated that the Commissioners would reconvene in approximately 25 minutes and no action would be taken in this Executive Session.

WHEREAS, the Commission has determined that it is in the District's best interest to amend the Separation Agreement to provide for the immediate distribution of the remaining amounts held in Mr. McCary's deferred compensation account and the release of the District's security interest in his life insurance policy pursuant to the terms of an amendment substantially in the form of the Amendment No. 1 to Employment Agreement attached hereto as Exhibit A (the "Amendment"); NOW, THEREFORE,

BE IT RESOLVED by the Commission of Public Hospital District No. 2, Snohomish County, Washington, as follows:

Section 1. The proposed terms of the Amendment are hereby approved and the Commission hereby delegates to the Superintendent and the Director of Finance of the District (each, an “Authorized Officer” and, together the “Authorized Officers”), and each of them acting alone, the discretionary authority to negotiate the final terms of the Amendment and to approve, execute and deliver the Amendment to Mr. McCary on behalf of the District.

Section 2. The Authorized Officers, and each of them acting alone, are hereby directed, and granted the discretionary authority, to execute and deliver any and all other certificates, documents, agreements and instruments that are necessary or appropriate in their discretion to give effect to this resolution and to consummate the transactions contemplated herein.

## AMENDMENT NO. 1 TO EMPLOYMENT SEPARATION AGREEMENT

This is an amendment to the Employment Separation Agreement, dated January 29, 2004, (the "Separation Agreement") between you, Stephen C. Nonqualified Deferred Compensation Agreement.** The District and you agree to honor the Nonqualified Deferred Compensation Agreement ("Deferred Compensation Agreement") dated December 15, 1995, as amended, except that the amounts payable as the result of the termination of the Employment Agreement shall be payable as follows so long as you comply with the terms of Section 13 of this Separation Agreement: (a) the amount on deposit in the account established pursuant to paragraph 2 of the Deferred Compensation Agreement, together with any investment earnings or losses, shall be paid to you in monthly installments beginning March 1, 2011, equal to 1/60<sup>th</sup> of the amount on deposit in the account as of that date and continuing to the earlier of the date on which (i) the entire amount on deposit has been paid or (ii) March 1, 2012, on which date the entire remaining balance on deposit in the account shall be paid to you; and (b) the Secured Amount, as defined in the Deferred Compensation Agreement, shall be paid to you on March 1, 2012. Until the amount on deposit in the account established pursuant to paragraph 2 of the Deferred Compensation is distributed to you or your estate pursuant to this agreement it shall be invested pursuant to your direction in one or more of the investment options available under the District's qualified retirement plans.

## EMPLOYMENT SEPARATION AGREEMENT

This is an agreement between you, Stephen C. McCary, and us, Public Hospital District No. 2, Snohomish County, Washington (referred to herein as “us,” “we” or the “District”). This agreement is dated for reference purposes as of the 29th day of January, 2004, which is the date we delivered this agreement to you for your consideration.

1. **Termination of Employment.** The Employment Agreement between you and us dated December 15, 1993, as amended (the “Employment Agreement”), and your employment by us, are terminated effective February 29, 2004 (the “Separation Date”).

2. **Payments.** In exchange for your agreeing to (a) the termination of the Employment Agreement, including forfeiting the severance payments and incentive award provided thereunder, (b) the modification of the Deferred Compensation Agreement (as defined below), (c) the release of claims described in this agreement and (d) the other terms in this agreement, we will make one hundred eighty-two (182) bi-weekly payments to you in the amount of \$6489.50 each. We will pay this amount to you on regular payroll days pursuant to our normal payroll procedures and subject to normal payroll deductions. We will provide you a federal tax Form W-2 Wage and Tax Statement on an annual basis. We will start paying this severance pay to you March 19, 2004, if the agreement has become effective on or before that date. If the agreement has not become effective as of March 19, 2004, we will begin payment on the first payroll date following the effective date of this agreement. The effective date of this agreement is described below in Section 18 of this agreement.

3. **Continuation of Medical Coverage.** Beginning March 1, 2004, and continuing for a period of twenty-four months, the District will provide you, at its cost, health, dental, and optical benefits under the District’s group plan at the same level provided to full-time employees of Stevens Hospital. Thereafter, you will be entitled to the opportunity to continue, at your own expense, your coverage under the District’s group health, dental and optical insurance plan during the period beginning with the twenty-fifth month and continuing until such time as you are eligible to be covered by Medicare. You, or your dependents in the event of your death, also will be entitled to the opportunity to continue, at your or their expense, coverage for your dependents under the District’s group health, dental and optical insurance plan beginning on March 1 and continuing until you and your spouse are eligible to be covered by Medicare. Because the District is providing you and your dependents the opportunity for medical coverage in excess of what is required by federal law (COBRA), you and your dependents agree to waive any rights you may have under COBRA. You and your dependents further agree not to apply for coverage under COBRA and to indemnify and hold the District harmless from any claim by you or your dependents arising under COBRA.

4. **Nonqualified Deferred Compensation Agreement.** The District and you agree to honor the Nonqualified Deferred Compensation Agreement (“Deferred Compensation Agreement”) dated December 15, 1995, as amended, except that the amounts payable as the result of the termination of the Employment Agreement shall be payable as follows so long as you comply with the terms of Section 13 of this Separation Agreement: (a) the amount on

deposit in the account established pursuant to paragraph 2 of the Deferred Compensation Agreement, together with any investment earnings or losses, shall be paid to you in monthly installments beginning March 1, 2011, equal to  $1/60^{\text{th}}$  of the amount on deposit in the account as of that date and continuing to the earlier of the date on which (i) the entire amount on deposit has been paid or (ii) March 1, 2016, on which date the entire remaining balance on deposit in the account shall be paid to you; and (b) the Secured Amount, as defined in the Deferred Compensation Agreement, shall be paid to you on March 1, 2016. Until the amount on deposit in the account established pursuant to paragraph 2 of the Deferred Compensation is distributed to you or your estate pursuant to this agreement it shall be invested pursuant to your direction in one or more of the investment options available under the District's qualified retirement plans.

5. **Split-Dollar Agreement.** The District and you agree to honor the Split-Dollar Agreement dated December 15, 1995 (the "Split-Dollar Agreement"), but in doing so acknowledge that upon your termination, the Split-Dollar Agreement is also terminated. The District and you acknowledge that upon the termination of the Split-Dollar Agreement, the District will have no further responsibility to pay any policy premiums and that the District's security interest in the policy shall remain intact according to the terms of the Split-Dollar Agreement.

6. **Continuation of Payments upon Death.** If you die while payments remain due pursuant to Section 2, the payments will continue to be made to your estate. If you die while payments remain due pursuant to Section 4 or 5, the payments provided therein shall be made to your estate within 90 days of your death.

7. **Termination of Benefits.** Except as expressly referenced in this agreement, your participation in all other employee benefit plans and programs ended or will end either (a) on the Separation Date, or (b) on the last day of the month in which the Separation Date fell, if so provided in the applicable benefit plan or program. Your rights under any retirement benefit plans in which you may have participated will be determined in accordance with the written plan documents governing those plans.

8. **Unemployment Benefits.** We will not contest your claim for unemployment benefits. We will provide information to the Department of Employment Security to the extent we are legally required to do so, and the information we provide will be truthful.

9. **Final Paycheck.** On the next regular payday after the Separation Date, we will pay you your normal wages for the most recent pay period through the Separation Date.

10. **Payment of Vacation and Sick Leave.** On the Separation Date, we will also pay you for any accrued, but unused vacation and sick leave you have as of the Separation Date. The pay out of vacation and sick leave shall be determined by multiplying the number of accrued, but unused vacation and sick leave hours by your Total Compensation (as defined in the Employment Agreement) for 2003, divided by 2080.

11. **No Further Compensation or Obligations.** You acknowledge that the payments identified above, together with the payments you have already received, represent full payment

of all compensation of any kind (including wages, salary, vacation, sick leave, commissions, bonuses and incentive compensation) that you earned as a result of your employment by us, except as otherwise set forth in this agreement. We owe you, and shall owe you, no further compensation or benefits of any kind, except as described herein. We acknowledge that you have no further obligations to the District, except as set forth in this agreement.

12. **Cooperation.** If, during the period payments are being made under this Separation Agreement, any claim is asserted by or against the District as to which you have relevant knowledge, you will reasonably cooperate with the District in the prosecution or defense of that claim, including by providing truthful information and testimony as reasonably requested by the District. In order to facilitate such cooperation, the District shall provide you, at its expense, with access to a cell phone, a voice mail telephone number and limited secretarial assistance for a period of twenty-four months following the effective date of this agreement.

13. **Agreement Not to Compete; Nondisclosure; No Inteference.** During the period beginning on the Separation Date and ending on March 1, 2016, you agree not to engage in, be employed by, consult with, support, assist, or become interested in, directly or indirectly, on your own account or in the service of others, any business or enterprise similar to, or the nature of which is competitive with, all or part of the business of employer anywhere in Snohomish or King County, Washington. You further agree not to solicit, induce, persuade, support or assist any officer, employee, agent, representative, broker, distributor, supplier, or customer of the District to leave such office or employment or cease to deal with Employer for the profit or benefit of yourself or any other person, firm, corporation, or for any other reason not in the best interests of the District.

You acknowledge and agree that the restrictions in this Section are reasonable in time, area, and scope. Any intentional or knowing use of confidential information in violation of this agreement, or use of confidential information that you should have reasonably known was in violation of this agreement, on behalf of a competing institution or entity in Snohomish or King county would be difficult to verify and would result in harm to the District. You further acknowledge and agree that the District would not have entered into this agreement without the restrictions in this Section, among others.

You will keep confidential, and not use or disclose to any person, any information not generally known to the public related to the District or its business.

You will not, apart from good faith competition, interfere with the District's relationships with its customers, employees, vendors, bankers or others.

You acknowledge and agree that any material violation of the provisions of this Section will result in termination of the payments and benefits provided under this agreement.

14. **Release of Claims.** You hereby release (a) the District and its subsidiaries, affiliates and benefit plans, (b) each of their past and present commissioners, officers, directors, agents, employees, representatives, administrators, fiduciaries and attorneys, and (c) the predecessors, successors, transferees and assigns of each of the persons and entities described in

this sentence, from any and all claims of any kind, known or unknown, that arose on or before the date you signed this agreement.

The claims you are releasing include, without limitation, claims of wrongful termination, claims of constructive discharge, claims arising out of agreements, representations or policies related to your employment, claims arising under federal, state or local laws or ordinances prohibiting discrimination or harassment or requiring accommodation on the basis of age, race, color, national origin, religion, sex, disability, marital status, sexual orientation or any other status, claims of failure to accommodate a disability or religious practice, claims for violation of public policy, claims of retaliation, claims of failure to assist you in applying for future position openings, claims of failure to hire you for future position openings, claims for wages or compensation of any kind (including overtime claims), claims of tortious interference with contract or expectancy, claims of fraud or negligent misrepresentation, claims of breach of privacy, defamation claims, claims of intentional or negligent infliction of emotional distress, claims of unfair labor practices, claims for attorneys' fees or costs (except as provided in Section 16 below), and any other claims that are based on any legal obligations that arise out of or are related to your employment relationship with us.

You specifically waive any rights or claims that you may have under the Washington Law Against Discrimination (RCW 49.60), the Washington Prohibited Employment Practices Law (RCW 49.44), the Washington Minimum Wage Act (RCW 49.46), Washington's Little Norris-LaGuardia Act (RCW 49.32), the Civil Rights Act of 1964 (including Title VII of that Act), the Equal Pay Act of 1963, the Age Discrimination in Employment Act of 1967 (ADEA), the Americans with Disabilities Act of 1990 (ADA), the Fair Labor Standards Act of 1938 (FLSA), the Family and Medical Leave Act of 1993 (FMLA), the Worker Adjustment and Retraining Notification Act (WARN), the Employee Retirement Income Security Act of 1974 (ERISA), the National Labor Relations Act (NLRA), the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA), and all similar federal, state and local laws.

You agree not to seek any personal recovery (of money damages, injunctive relief or otherwise) for the claims you are releasing in this agreement, either through any complaint to any governmental agency or otherwise. You agree never to start any lawsuit or arbitration asserting any of the claims you are releasing in this agreement. You represent and warrant that you have not initiated any complaint, charge, lawsuit or arbitration involving any of the claims you are releasing in this agreement.

You represent and warrant that you have all necessary authority to enter into this agreement (including, if you are married, on behalf of your marital community) and that you have not transferred any interest in any claims to your spouse or to any third party.

This agreement does not affect your rights to receive pension plan benefits, medical plan benefits, unemployment compensation benefits or workers' compensation benefits. This agreement also does not affect your rights under agreements, bylaw provisions, insurance or otherwise, to be indemnified, defended or held harmless in connection with claims that may be asserted against you by third parties.

You understand that you are releasing potentially unknown claims, and that you have limited knowledge with respect to some of the claims being released. You acknowledge that there is a risk that, after signing this agreement, you may learn information that might have affected your decision to enter into this agreement. You assume this risk and all other risks of any mistake in entering into this agreement. You agree that this release is fairly and knowingly made.

15. **Reference Checks.** The District will respond to reference checks pursuant to its normal policy, that is, it will provide only dates of employment, position held and compensation level, and you hereby consent to the release of that information.

16. **Independent Legal Counsel and Advisors.** You are advised and encouraged to consult with an attorney before signing this agreement. You acknowledge that you have had an adequate opportunity to do so. The District will reimburse reasonable expenses incurred by you in 2004 for legal, accounting, tax preparation, outplacement and financial services, but in no event to exceed \$2000.

17. **Consideration Period.** You have 21 days from the date this agreement is given to you to consider this agreement before signing it. You may use as much or as little of this 21-day period as you wish before signing. If you do not sign and return this agreement within this 21-day period you will not be eligible to receive the benefits described in this agreement.

18. **Revocation Period and Effective Date.** You have seven (7) calendar days after signing this agreement to revoke it. To revoke this agreement after signing it you must deliver a written notice of revocation to our Human Resources Manager before the seven-day period expires. This agreement shall not become effective until the eighth (8th) calendar day after you sign it. If you revoke this agreement it will not become effective or enforceable and you will not receive the benefits described in this agreement.

19. **Governing Law.** This agreement is governed by the laws of the state of Washington that apply to contracts executed and to be performed entirely within the state of Washington.

20. **Headings Not Controlling.** The headings in this agreement are for convenience only and shall not affect the meaning of the terms as set out in the text.

21. **Attorneys' Fees.** To the extent permitted by applicable law, the District will pay to you all out of pocket expenses, including reasonable attorneys' fees, incurred by you in connection with any claim or any legal action or proceeding brought under or involving this agreement, whether brought by you or by or on behalf of the District or by another party, except in connection with any claim, action, or proceeding in which you and the District are adverse parties (except where they are caused to be adverse by reason of actions of any third party). In such an instance, should the District prevail in any matter adverse to you, then the District shall be entitled to its reasonable attorneys' fees, costs and disbursements from you.

22. **Final and Complete Agreement.** This agreement, along with the Deferred Compensation Agreement and the Split-Dollar Agreement, are the final and complete

**expression of all agreements between us on all subjects and supersedes and replaces all prior discussions, representations, agreements, policies and practices. You acknowledge you are not signing this agreement relying on anything not set out here.**

## January 2012 Program Oversight Committee Summary

### Summary of January Applications

- Follow up on previous proposal from Puget Sound Christian Clinic for their Mobile Medical Clinic
- 5 new applications from 5 different organizations
- Priority areas addressed (some address more than one):
  - 1 Access to Healthcare
  - 4 Prevention
  - 3 Education & Empowerment
  - 1 Policy & Advocacy

### Programs Recommended for Funding

- **Puget Sound Christian Clinic for their Mobile Medical Clinic:** after completing a question and answer session with the clinic, the committee is recommending the program for partial funding at \$75,000 per year through the end of 2013. Funding would be contingent on Puget Sound Christian Clinic obtaining professional liability insurance.
- **Parent Trust Continuum of Family Support Services:** the program provides parenting education and support, including support for parents in chemical dependency recovery at Lynnwood, Edmonds, and Mountlake Terrace locations. The committee is recommending the program for funding at \$25,000 per year for two years.
- **American Red Cross Snohomish County Chapter CPR Saturday:** a free community event that provides CPR training in English & Spanish at the Lynnwood Convention Center. The committee is recommending funding at \$8,000 on a one-time basis.

### Not Recommended for Funding at this time:

- **Providence Hospice & Home Care Foundation:** the committee would like Verdant staff to follow-up with Providence Hospice to structure a proposal around education and outreach for hospice services with the goal of increasing awareness and use of these services within our district.
- **Snohomish Health District Farm-to-School Project:** the committee is not recommending the proposal for funding at this time. The committee felt the expected results outlined in the proposal did not warrant the cost of \$241k per year for three years. The committee would have liked to see stronger commitment from the Edmonds School District/Edmonds Community College, and would like to address other food policy issues at schools such as snacks available for sale.
- **Terrace Park PTA:** the application was for funds to construct a covered outdoor play area at Terrace Park Elementary School. The committee is not recommending funding this project, as it could set a precedent for funding capital needs at other schools.

### **Commission for Health Priority Areas**

- 1. Education & Empowerment:** We support programs that educate and empower residents to live healthy lives. These include programs that give people the tools to take ownership of their health, increase their knowledge of health issues and availability of resources, and provide motivation to improve their well-being.
- 2. Prevention:** We support prevention programs, including those that promote health and wellness and that provide early detection and treatment. Of particular interest are programs that increase healthy behaviors, support necessary health screenings, and prevent injuries.
- 3. Access to Healthcare Services:** Too many residents in our area go without needed healthcare services. We support programs that increase access to medical, dental, and behavioral healthcare services. Of particular interest are programs that serve pregnant or parenting mothers and fathers and the uninsured or underinsured community members.
- 4. Policy and Advocacy:** We support programs that employ advocacy and public policy improvements to health systems, communities, and organizations to better meet the health and wellness needs of our residents.
