Call to Order	The Regular Meeting of the Board of Commissioners of Public Hospital District No. 2, Snohomish County, was called to order at 8:00 a.m. by President Knowles.
Approval of Minutes	Motion was made, seconded and passed unanimously to approve the minutes of the regular board meeting on March 24, 2021. (E:22:21)
Community Presentation	Ms. Piplic introduced Ms. Jolly and Ms. Frizzell, Jean Kim Foundation Board Members, and Ms. Bell and Ms. Simmons from the Lynnwood Hygiene Center. Ms. Piplic gave a brief overview of the presentation and video and acknowledged Mr. Franco, Verdant's Social Media Intern, for filming and editing the video taken at the Lynnwood Hygiene Center that was played as part of the presentation.

Ms. Frizzell stated that the Hygiene Center started operation a year ago on April 5, 2020. Since the center has been open, they have offered 6,827 showers to 738 different people and this year Ms. Frizzell anticipates the number of showers offered to go up to 8,600 in the first quarter of 2021. Ms. Frizzell mentioned Jeff Butler, the owner of the building, and shared the news that the building will be available for the Hygiene Center's use for another year. Ms. Frizzell thanked Verdant for the support and partnership and acknowledged Hygiene Center employees Ms. Bell and Ms. Simmons for their good work and how they have become very trusted and respected employees.

Ms. Jolly reported that she has spent time at the Hygiene Center meeting with the clients to help them renew their documents such as ID cards, apply for support through DSHS, and create online accounts.

President Knowles thanked Ms. Frizzell, Ms. Jolly, and staff and said that it is good to know that Verdant resources are going to supporting such an important community service.

Commissioner Knutsen commented that her family sees a lot of people using the Hygiene Center as they live close by, and she appreciates what a great job that the center is doing.

Secretary Distelhorst thanked Ms. Frizzell and staff for providing this service and for helping people get back into school and finding employment.

Superintendent<br/>ReportDr. Edwards reported that April has been busy a month at<br/>Verdant with community engagement. Dr. Edwards and Ms.<br/>Reese visited the Washington Kids in Transition site and assisted<br/>in packing food and staff have dates on the calendar to visit<br/>other organizations that Verdant is supporting.

Dr. Edwards toured Swedish Hospital to learn about the capital improvements made in 2020 and so far in 2021. Dr. Edwards has asked for a report on improvements that are on hold or delayed plus future planned capital projects in 2022. That report was recently shared with commissioners.

Ms. Reese, Ms. Keuser and Dr. Edwards visited the Kruger Clinic with Mike Denney, Swedish's Chief Real Estate Officer. There was discussion about how the leased offices are currently being utilized by the hospital and the possibility of moving billable services from the hospital to Kruger Clinic to free up needed space.

Dr. Edwards attended the CEO Roundtable discussion on April 12. A presentation was given by the families of Tigray, Ethiopia.

	The family members are asking for elected officials to advocate on their behalf for intervention to stop civil war and unrest and many of the speakers have lost 5-7 family members. Dr. Edwards would like to explore how Verdant can help support these families.
	Dr. Edwards met with South County Fire on April 20 to discuss their interest in the Value Village Property and also met with the co-owners of the Party Store. Additional meetings were had with City planners and developers to better understand the impact on low-income housing when the light rail station opens.
	The Everett Herald has invited Dr. Edwards to participate in a Saturday blog/forum on positive topics about our community. Ms. Piplic and Dr. Edwards will be working together on the articles that will be forwarded to commissioners for approval before being published.
Executive Committee Report	President Knowles reported that the committee met on Wednesday, April 21, 2021 to review the agenda for the April 28, 2021 board meeting. No action was taken.




# Asset Breakdown (in millions)






# 2020 Operating Expenses

Suicide is a serious public health problem in Washington. It affects people of all ages in communities across the state. Because suicide is one of the leading causes of early death, preventing it improves the health of our communities.

Understanding the warning signs and ways you can help can make a difference.

# One Conversation Can Change a Life.

# Warning signs may include:

- Talking about wanting to die or kill oneself
- Looking for a way to kill oneself
- Talking about feeling hopeless or having no reason to live
- Talking about feeling trapped or being in unbearable pain
- Talking about being a burden to others

# Ways you can help:

- LISTEN non-judgmentally
- Refrain from touching without permission: "Can I put my hand on you to help calm you?"
- Speak in a calm voice. Useful things to say include: "I am concerned about you... can I get you help?"
- Reassure the person they are heard
- Encourage the person to seek support from resources or family or friends: "Is there anyone at home? Could we call the crisis line together?"
- Understand that mental health and substance use issues can cause erratic or unpredictable

- Increasing the use of alcohol or drugs
- Acting anxious or agitated; behaving recklessly
- Sleeping too much or too little
- Withdrawing or feeling isolated
- Showing rage or talking about seeking revenge
- Displaying extreme mood swings

behavior and people can exhibit a range of symptoms. Auditory or visual hallucinations and odd behaviors can be common.

- If you feel the person is suicidal, be specific when you call 911: "Could you send an ambulance or paramedics? Someone's in distress."
- Try not to let emotion take over. Keep descriptions accurate and objective.
- Warn emergency workers that they may be dealing with a mental health crisis. It could save lives.

# V. Recent Grantee report highlights

## a. Edmonds College Foundation

- Provided 100 meals weekly and served266 unduplicated students via the Campus Pantry which distributed 18,118 pounds of food.
- "Verdant made a huge impact on students in housing. We had 60 students that were provided meals in housing each week...many were struggling financially due to losing their job and/or not feeling safe to go to a job. The food was bright light both financially and emotionally. Many made comments how the food was the most nutritious and tasteful food they had for the week" – Director of Housing and Residence Life

## b. Helping Hands Project Organization

- \$48,560 in rental assistance (paid directly to landlords/property managers) provided to 17 families (average of \$2,856 per family) and \$18,000 of food support provided to over 70 households.
- One request they received for PHD2 that they were able to respond to was "I am now in need of rent and groceries assistance as I look for not employment. Kindly assist me however you can. I

have too many bills including food and I have sleepless nights thinking about my bills. I am providing for my 4 kids and myself"

# c. Lahai Dental

- Provided 539 appointments with 85% of program participants having no dental insurance (61% uninsured and 24% Medicare only), 94% of participants at or below 30% of area median income (considered "very low income"), and 45% speaking a language other than English.
- "90% of patients return to complete the Dentist's recommended services...our staff places particular emphasis on ensuring that our patients know they are valued and cared for"

# VI. COVID Testing and Vaccination update


- a. Mass vaccination site (SVNA, Edmonds College) YTD: 35,340 vaccinations. All Mass Vaccination sites in Snohomish County have moved to a "flex" model where appointments are preferred, but not required, and folks can walk-up/drive-up and be registered onsite.
- b. Adult Family Home vaccinations YTD: 98 facilities visited and 2,629 vaccinations given. Have now transitioned to Community Pop-Up events via grant mod of VIP contract.

# VII. Community Engagement Update

- a. Selected to join the Board of Partnership to End Homelessness representing HealthCare and Philanthropy Sectors as well as the Data and Evaluation and EDI Outreach Committees. She is also representing Verdant on the UW Bothell Healthcare Advisory Board, the Snohomish County COVID-19 TaskForce, and the regional Dental Access Coalition.
- b. Visited the Diversion Center with Lynnwood and MLT Police Departments, Millennia Ministries, Pacific Treatment Alternatives, Washington Kids in Transition, and staffed a community COVID Vaccine event with Korean Women's Association, Ethiopian Orthodox Church, and South County Fire.

# VIII. Fluxx Implementation Update

- a. Transition is underway! Zoe and Thea translating our paper forms and email-based processes into programmable excel spreadsheets and workflow documents.
- b. Discovery and development of initial version to be completed by Fluxx in June
- c. Testing and refinement with staff involvement to occur in July followed by training
- d. Internal and External Communication planning began at 5/7 VPR and will continue throughout summer.
