Call to Order

The Regular Meeting of the Board of Commissioners of Public Hospital District No. 2, Snohomish County, was called to order at 8:01 a.m. by President Knowles.

Approval of Minutes

**Motion was made, seconded and passed unanimously to approve** the minutes of the regular board meeting on June 23, 2021. (E:44:21)

Community Presentation

Ms. Reese introduced Ms. Rigel, Board President of Washington State School-based Health Care Alliance. Ms. Rigel's presentation included the history and overview of the school-based health care program highlighting the benefits of reducing the barriers to health care and increasing accessibility for the students in need of services. (E:45:21)

Ms. Reese presented a short video of the Sedro Woolley Schoolbased Health Center.

# **Community Presentation**

Ms. Reese introduced Ms. Barnes, Social Services Senior Manager at Homage. Ms. Barnes talked about the Verdant funded program Senior Tech Connect and the impact it has had on the senior participants.

Mr. Johnson, CEO at the Edmonds Waterfront Senior Center introduced 83-year-old Ms. Ohtomo who has been involved on the board and various committees at the Edmonds Waterfront Senior Center and has been an advocate for the Senior Tech Connect program.

Ms. Ohtomo spoke about her introduction to technology and how at first she was resistant to learning. Now she is helping to connect others with the Senior Tech Connect program and encouraging them to accept technology as a good form of communication.

Mr. Johnson introduced Mr. Rice, a sophomore at Edmonds-Woodway High School, who has been instrumental in the success of the program. Prior to this pilot program's launch, he started his own non-profit to help seniors work with technology.

Mr. Rice talked about helping his grandparents with tech challenges and decided to expand services to more seniors and reached out to Mr. Johnson. Mr. Rice has been providing 1:1 training and assistance to seniors on tablets and smart phones helping to bridge the gap between the generations.

# Superintendent Report

Dr. Edwards reported that the during the past month the Verdant team has created hybrid and in-person classes in addition to the virtual classes that are already being offered. Marketing has been developing icons for promotional materials to easily distinguish between in-person classes, virtual, and hybrid. Starting August 2, the VCWC will be open for the public from 9:00 a.m.-4:00 p.m. Monday through Friday. Verdant has hosted two South County Walks and two Meet Me at the Park events for the community. Verdant continues to work with Swedish Hospital Edmonds and met with the design firm of NBBJ on June 30 to plan for updating the Kruger Clinic exterior and interior common spaces to match the hospital. Swedish Edmonds hired NBBJ for this portion of the project. The RFP for construction will be drafted as soon as the design work is completed in early September 2021 and the RFP for the Wellness Center will be happening in tandem. Dr. Edwards announced that Verdant has released two RFOs for the leadership of the CHART program and a DEI Consultant.

# Executive Committee Report

President Knowles reported that the Executive Committee met on Wednesday, July 21, 2021 to review the agenda for the July 28, 2021 board meeting. No action was taken. President Knowles announced that commissioners have been working with Turner HR Services on an engagement survey that will be emailed out for feedback and asks that the survey be completed in a timely manner.






- a. **COVID vaccine** efforts have now transitioned to community-based events and supportive marketing/information strategies.

With rising case counts, we decided to continue with all VIRTUAL programming, but we now have the infrastructure in place to offer in-person programming when safe for the community to attend.

#### **Verdant Community Social Worker Highlights**

Nancy Budd, Community Social Worker

- Case Management continuing support for 8 clients. CHART continuing support for 6 clients during this period; one client added to CHART due to multiple hospital visits recently. Several clients were very active this month, with multiple crises, involuntary commitments, and suicidal behaviors. Several have improved their health through accessing treatment for substance use and mental health.
- This past month included weekly team check ins, monthly staff meeting, grant update meetings, monthly County Outreach Coalition, and County and Human Services Providers meeting. Monthly Snohomish County Community Behavioral Health Committee and Snohomish County Connector's meeting. Webinar: Rising to the Challenge of Supporting People with Hoarding Behaviors and Excessive Clutter. Seven-hour Accountable Communities of Health (ACH) required partner convening.
- I have worked 2.5 months at Swedish Edmonds, one day per week. I coordinate work between the psychiatric unit (9W), the emergency departments behavioral health assessment team (BHAT), and the hospital case management team. The goal is to begin to build rapport with clients before their discharges, in hopes of obtaining better health and wellness outcomes outside of the hospital setting. To date, 14 referrals since 6/01/21. Of these, 2 were consultations, and referred to more appropriate resources. 3 are unknown status at this time, as clients went into other inpatient settings. However, I did meet with them before their discharges with possible follow ups when discharged from current setting. 3 clients did not follow up with me after discharge. I have 6 new active clients from this referral source.
- New virtual behavioral health provider training scheduled for September 21, 2021 to include 3 CEUs. When identifying subjects for trainings, I reach out to the provider community for possible subjects. Many providers suggested self-care subjects this time. Therefore, the class is titled: Burnout and Vicarious Trauma in the Workplace: Fostering Healthcare Professionals Resilience, Prevention, and Treatment Strategies.

Presenter Information: Dr. Lucy Cannon, Ed.D, LCSW, CCDP-D, MATS Expert Trainer, Expert Facilitator. Dr. Roberts-Cannon is the CEO/Owner of LEJ Behavioral Health Services, LLC, a training and consulting company in Metropolitan Atlanta. Dr. Roberts-Cannon has been a clinician, supervisor, director, and consultant of mental health and co-occurring disorders programs in inpatient and outpatient healthcare organizations and psychiatric hospitals in various states in the United States. She is also a national trainer on various mental health and co-occurring disorders topics. She is a trainer and facilitator for the Department of the Navy Reserve and Yellow Ribbon Programs. She is an Adjunct Professor at Clark Atlanta University School of Social Work. She serves on various healthcare organizations boards of directors and advisory boards in Metropolitan Atlanta.

• Worked with South Snohomish County Fire and Rescue to schedule a de-escalation training for those staff that will be called to behavioral health calls (CRPs, Battalion Chiefs, MSOs). The Captain of the CRP team informed me that they are seeing an almost 100% increase in the 2 weeks before HB1310 (police use of force) and the 2 weeks after bill was initiated. The training will be held on October 1, 2021. The trainer is Ellis Amdur (Edgework Crisis Intervention Resources PLLC), and he is one of the most prominent trainers in the Pacific Northwest on verbal de-escalation of aggressive and mentally ill individuals. This training is tailor-made for the Fire Department and is titled Cooling the Flames.

### **Marketing Report**

Jennifer Piplic, Director of Marketing and Communications

#### **Website Redesign**

This month, Aukema & Associates created an online survey in English and Spanish to gain feedback on the interests and preferences of our community regarding website content and usability, which resulted in almost 200 responses. These responses are being analyzed currently and will create the foundation for the focus groups held the week of Aug. 23 (one in English and one in Spanish) to dive more deeply into the themes generated through the survey.

While seeking this feedback, we are working on the wire frames for the site and will use the feedback received through this process, leading up to design review in the weeks to come. The current timeline includes finalizing the design and content in September, with site development taking place by mid-October. The timeline for training and go-live will be determined in the coming month as the design and content is finalized.

#### Social Media

During the previous 4-week period, we have seen steady growth in followers and marginal growth in reach, with a net increase of 9 followers (to 1,148) and 6,900 people reached. This last month we began implementing Facebook stories, and they are proving to be successful. We reached 94 unique individuals and produced 11 engagements through this passive, low-effort tactic. We continue to use social media to promote classes and events, share COVID information, and highlight our work in the community. With the support of the social media intern, we are testing different strategies in an effort to move beyond people seeing our posts as they scroll by and moving to a higher level of engagement.
