Call to Order	The Regular Meeting of the Board of Commissioners of Public Hospital District No. 2, Snohomish County, was called to order at 8:01 a.m. by President Knowles.
Approval of Minutes	<i>Motion was made, seconded and passed unanimously to approve</i> the minutes of the special board meeting on September 26, 2020. <i>Motion was made, seconded and passed unanimously</i> to approve the minutes of the regular board meeting on September 26, 2020. <i>Motion was made, seconded and passed unanimously</i> to approve the minutes of the special board meeting on October 14, 2020.

Superintendent Report

Dr. Edwards reported on the following items:

1. Verdant Operations update: See the Verdant Program & Marketing Highlights sheet for the activities that are currently underway.
2. Outreach to Edmonds Rotary, Homage, and Domestic Violence Services has been occurring. Thank you to Ms. Piplic and Ms. Waldin for their work on the grant modifications. The program work will transition to Ms. Reese.
3. Next Steps for Value Village property – the property is currently empty and car camping has been occurring in the parking lot. Current lease expires December 31, 2021.

Verdant has received a request from the City of Edmonds and the City of Lynnwood to use the property as a cold weather shelter with COVID restrictions and ready to use by Thanksgiving. Use will be inconsistent as the shelter is weather dependent and open when the temperature drops below 32 degrees for four hours or more but an estimate of 25 nights is possible. Superintendent Edwards will look in to concerns about proper ventilation and use of air filters.

Verdant also received a request from Holly House in Lynnwood to use the property for Holiday gift distribution. Commissioner Wilson mentioned that the Verdant Community Wellness Center could also be used for this gift distribution project.

Mr. Berg is reviewing the Value Village lease from 1997 to current to see if any restrictions on building usage and also looking at a lease forgiveness option.

Other interested developers, a gym owner, and South County Fire are also interested in the property. President Knowles noted that no action would be taken on the Value Village property at this meeting.

Mr. Berg joined the meeting at 8:43 a.m. and gave the board the two options for the lease:

1. Leave the current lease in effect and Verdant can negotiate the right to use the space,
2. Negotiate the termination of the

existing lease and tenant would pay some amount of the remaining lease that would have ended in December 2021. If the property is used for a shelter, the zoning and land use permit would need to be examined and the responsibility for the shelter would need to be considered.

Dr. Edwards noted that a zoning variance could be obtained from the City of Edmonds, Volunteers of America would be the fiscal agent for the staffing of the shelter, and there is possible funding from Snohomish County. Commissioners discussed their preference to not leave the building empty but use it for a cold weather shelter this winter as long as extensive tenant improvements are not needed.

4. Feasibility study for pediatric 16-bed inpatient behavioral health facility will cost approximately \$14,000. All commissioners agreed that they need the data from a study to make a decision. Dr. Edwards will move forward with the study (E:63:20)

Executive Committee Report

President Knowles noted that the committee met on October 21, 2020 to review the agenda for the October 28, 2020 board meeting and to work on the agenda for the December 1, 2020 special meeting. No action was taken.

Finance Committee Report

The committee met on October 20, 2020. Ms. Ash reviewed the financial statements and cash activity for September 2020 (E:64:20).

Authorization for Payment of Vouchers & Payroll

Warrant Numbers 14437 through 14485 for September 2020 for payment in the amount of \$91,081.66 were presented for approval (E:65:20) by Commissioner Langer. ***Motion was made, seconded and passed unanimously to approve.***

Ms. Ash noted that the surplus asset is a Siemens CT scanner originally purchased in 2005 for \$807,000 and with a five year life span.

**Program Committee
Update**

The Program Committee met on October 22, 2020.

Commissioner Distelhorst welcomed Ms. Reese to Verdant and indicated that there are 20 modifications to contracts totaling \$6,352,823 and 3 Superintendent Discretionary fund programs totaling \$58,200.

See Exhibit E:66:20 for the complete list.

No conflicts of interest were reported by the commissioners.

Commissioners discussed if current grants should continue to be renewed. Program Committee prefers grant extensions to 2021 rather than renewals as there is so much uncertainty around COVID-19 and the grant extensions will give Verdant time to re-assess its funding priorities.

Commissioner Wilson inquired about the Center for Human Services (CHS) and THS grants. Dr. Edwards replied that CHS is doing more outreach and their

deliverables have been adjusted by 25%. THS depends on CHS for referrals but have also been doing more outreach and publicity. November 10, 2020 is their next report date to Verdant which will be shared with the Program Committee. Program Committee decided to sustain the grant funding to THS until December 31, 2020 and re-evaluate at that time.

Commissioner Distelhorst presented the renewal application for approval.

Recommendations**

Motion was made, seconded and passed unanimously to approve the extension of current contract and funding level for the Edmonds Senior Center Enhance Wellness/PEARLS/Foot Care Program in the amount of \$135,324 for November 1, 2020 to December 31, 2021.

Dr. Edwards reported that there will be a total of six discussion meetings with community leaders. Three of the six meetings will be public meetings as there will be a quorum of commissioners in attendance: Food Insecurity, Domestic Violence, and Housing. Commissioner Knowles will send some names of potential experts in Vision Care to Dr. Edwards.

Verdant Community Wellness Center Report

Addressing Food Insecurity:

- Distributed 1330 Fruit & Veg. Vouchers since April, 2020 to food insecure residents thru 7 partners
- Staff lead on CEO Food Insecurity Roundtable. Summarizing recommendations for Board consideration at the strategic priorities meeting in December.

Modifying programming to serve vulnerable, at-risk populations virtually:

- Offering a 4-week “Diabetes-friendly Living” series in partnership with PHD#3 10/26 – 11/16. 10 Participants from Verdant and 4 participants from Stilly Valley Health Connections in Arlington

Offering behavioral health resources for the community virtually:

- 8-week Managing Difficult Emotions Support Group in progress: 10/21 – 12/16 8 participants
- Offering COVID telehealth counseling for residents experiencing heightened anxiety/depression (up to 10 individualized sessions to address behavioral health issues exacerbated by COVID & social isolation)

Virtual Programming:

- Cooking for One or Two: 10/28/20 12 participants (frequently requested session to help seniors stretch their food dollars, learn tips for healthy, easy recipes, and reduce food waste)
- Cooking with Confidence 3-part Series 12 participants on 11/3 11 participants on 11/3 (a cooking demo & discussion about foods and cooking techniques facilitated by a Dietitian with a goal to get people back in the kitchen incorporating healthier food options into everyday eating patterns)
- Bang for your Buck: budget-friendly foods & recipes 11/12/20 – 14 participants (session showcased cabbage as an economical and healthy vegetable option to stretch food dollars)

Note: Sue Waldin is assisting with efforts to use the Value Village property as an additional cold weather shelter this winter to provide extra overnight beds during COVID. Sue is the Verdant staff lead supporting the bilingual Community Resource Advocate in partnership with VOA and Edmonds College.

Verdant Community Social Worker Highlights: November 2020

- Successful first virtual Provider Training, with 38 attendees. The subject was Solution-focused Brief Therapy, and the instructor was Lara Okoloko.
- Set up and funded three first responder trainings for mental health and wellness. The agencies involved are South County Fire and Rescue, Lynnwood, Edmonds, MLT PDs, and Sheriff's department. The trainings will be taped and will be mandatory for personnel. Expected attendance of 540.
- Semi-annual reporting to the Accountable Communities of Health completed and submitted.
- Attended quarterly Violence Prevention CCRT meeting (Edmonds College), all CEO roundtables, monthly Outreach Coalition meeting, and monthly Homeless Policy Task Force meeting.
- Case Management – Continuing support for 8 residents with complex medical and behavioral health conditions. During the pandemic, several clients have faced increased behavioral health and medical issues. I have worked closely with several to work towards improved overall health and wellness.

One of my chronically homeless CHART clients appeared, and I was able to work with her some. I continue to receive police and hospital reports on other missing clients.

- One client in particular contracted Covid-19 and is currently in isolation. She has severe underlying medical and behavioral health conditions. I was able to provide food, household items and medical supplies (oximeter and thermometer). I set her up with several outreach services so she does not feel as isolated: Lynnwood Connect (City of Lynnwood - weekly call for general support), Covid Connect (Homage – weekly mental health support), and a Verdant funded mental health program through Sound Choices Counseling for a weekly mental health/covid support call. She has also been accepted to one of Homages programs - they will be providing her a tablet for telehealth services.
